

# **Public Offer Agreement for participation in the Digital Bridge - 2025 International Technology Forum**

The Innovative Technologies Park Autonomous Cluster Fund, hereinafter referred to as the Fund, represented by Madiyev M., the General Director, acting on the basis of the Charter, proposes to provide services of participation in the Digital Bridge - 2025 International Technology Forum (the Forum) in the manner and on the terms and conditions specified in this Public Offer Agreement (the Offer) to any individual, hereinafter referred to as the Participant, the Fund and the Participant are hereinafter jointly referred to as the Parties, and separately as the Party.

## **1. General provisions**

1.1. The Fund publishes this Offer with a proposal addressed to individuals in accordance with Articles 395, 396 of the Civil Code of the Republic of Kazakhstan.

This Offer has legal force and is equivalent to the agreement signed by the Parties.

1.2. This Service Offer for participation in the Digital Bridge - 2025 International Technology Forum as a Participant of the Forum with Early bird, Standard and VIP tickets is an official document containing all material terms and conditions of the Service Offer and is published on the official website of the Forum (<https://digitalbridge.kz/>).

1.3. The unconditional acceptance (full and unconditional acceptance) of the terms of this Offer is the Participant's actions to fill out the registration form for participation in the Forum posted on the official website of the Forum (the Registration Form).

1.4. Upon completion by the Participant of the Registration Form for participation in the event posted on the official website of the Forum (<https://digitalbridge.kz/>), all information provided in the Registration Form shall constitute the basis of the Offer between the Fund and the Participant.

1.5. This Offer consists of the accepted public Offer and its integral parts, as well as other documents posted on the official website of the Fund.

## **2. Subject of the Offer**

2.1. The Fund undertakes to provide services of participation in the Digital Bridge-2025 International Technology Forum with Early bird, Standard and VIP tickets in accordance with the terms and conditions of this Offer, and the Participant takes part in the event and undertakes to pay for the services provided by the Fund in full.

2.2. Complete information about the Service, is available on the official website of the Forum.

2.3. Date and venue of the Forum: from October 2 to 4, 2025, Astana, 53/1 Mangilik Yel Ave., EXPO International Exhibition Center.

## **3. Rights and obligations of the Parties**

3.1. A Participant has the right to take part in the Forum.

3.2. A Participant has the right to withdraw from participation in the Forum by notifying the Fund, subject to the provisions of Chapter 5 of this Offer.

3.3. The Participant assumes the following obligations:

3.3.1. Comply with all requirements of the current legislation of the Republic of Kazakhstan when exercising rights and fulfilling obligations under this Offer. During participation in the Forum, observe safety regulations, fire safety, sanitary rules and standards of conduct.

3.3.3. Pay for participation in the Forum on time and in the manner specified in Chapter 4 of this Offer.

3.4. The Fund assumes the following obligations:

3.4.1. Comply with all requirements of the current legislation of the Republic of Kazakhstan when exercising rights and fulfilling obligations under this Offer.

3.4.2. Provide Services in accordance with the terms of this Offer.

3.4.5. In case of changes in the terms of the Forum (dates, venues), notify the Participant at least 10 (ten) business days before the start of such changes on the official website of the Fund and/or by e-mail.

3.5. The Fund shall be entitled to:

3.5.1. Change the date and venue of the Forum by notifying the Participant no later than ten (10) business days prior to the date of the Forum.

3.5.2. The Fund shall be entitled to engage third parties to provide services under this Offer, while remaining liable to the Participant for fulfillment of its obligations hereunder.

3.5.3. Not to fulfill the obligations hereunder and not to allow the Participant to participate in the Forum, if the monetary funds hereunder have not been transferred to the Fund's settlement account or their transfer is not confirmed by a payment order, as well as in case the Participant violates other terms and conditions of this Offer.

#### **4. Payment procedure**

4.1. The total ticket price of this Offer, including VAT, is:

1) Early bird ticket:

- until June 1, 2025 – KZT2,990;
- until September 1, 2025 – KZT5,990;
- until October 1, 2025 – KZT9,990.

2) Standard ticket:

- from October 2 to October 4, 2025 (during the Forum) – KZT14,990.

3) VIP ticket:

- until September 1, 2025 – KZT499 000;
- after September 1, 2025 – KZT699 000.

4.2. Payment for services under this Offer shall be made by the Participant on the terms of 100% prepayment, by transferring funds to the Fund's settlement account and/or paying by bank/credit card of partner banks.

4.3. The date of payment shall be the date of receipt of funds to the Fund's settlement account and/or the date of acceptance of payment by the partner bank.

#### **5. Refusal to participate**

5.1. The participant must notify the Fund in writing (according to the Application in the Annex with obligatory attachment of a scan of the ID/passport document) of his/her

refusal to participate in the Forum within 14 calendar days from the date of payment for the ticket. Tickets purchased beginning September 15, 2025 are non-refundable.

In this case, the amount paid by the Participant shall be refunded minus actual expenses (Bank commissions) incurred by the Fund.

5.2. If the Participant fails to participate in the event for reasons beyond the control of the Fund and fails to notify the Fund within the above-mentioned time limits, as well as in case of impossibility of performance due to the Participant's fault, the Fund shall not refund the money received from the Participant for the services rendered.

5.3. The Fund shall refund the money to the Participant within 30 (thirty) calendar days from the date the Fund receives the Participant's notice of refusal to participate in the Forum.

## **6. Liability of the Parties**

6.1. For failure to fulfill or improper fulfillment of obligations under this Offer, the Parties shall be liable in accordance with the current legislation of the Republic of Kazakhstan and this Offer.

6.2. The Fund shall ensure the general security of the Forum, round-the-clock protection of public order in the Forum territory and shall not be responsible for the safety of the Participant's property.

## **7. Force Majeure**

7.1. The Parties shall be released from liability for partial or full non-fulfillment of obligations under this Offer, if such non-fulfillment was caused by force majeure circumstances arising after the conclusion of this Offer. For purposes of this Section, Force Majeure shall mean an event beyond the control of the Parties and of an unforeseeable nature. Such events may include, but are not limited to, actions such as acts of war, natural or act of God, epidemic, quarantine, embargo, and others.

7.2. In case of Force Majeure, the Party for which it is impossible to fulfill its obligations shall notify the other Party of the expected duration of Force Majeure in writing (notification) within 5 (five) calendar days from the moment of occurrence of such circumstances and their causes, as well as provide documents confirming the fact of occurrence of such circumstances issued by the competent authority. Failure to notify or untimely notification of the occurrence of Force Majeure shall deprive the Party of the right to invoke any unforeseen above-mentioned circumstance as a ground exempting from liability for failure to fulfill its obligations.

7.3. If the Forum is canceled due to Force Majeure, the obligations of the Parties arising from the terms of this Offer shall be null and void. The Fund shall return the monetary funds paid by the Participant to the Participant minus the expenses actually incurred (commission fees of the Bank) related to the provision of services by the Fund.

## **8. Dispute resolution procedure**

8.1. All disputes and disagreements that may arise between the Parties from this Offer shall be settled by negotiations.

8.2. If as a result of such negotiations the Parties are unable to resolve a dispute hereunder, any of the Parties may demand that the matter be resolved in court in accordance

with the laws of the Republic of Kazakhstan. All matters not regulated by this Offer shall be governed by the laws of the Republic of Kazakhstan.

### **9. Validity period of the Offer**

9.1. The Offer shall become effective from the moment of its acceptance and shall remain in force until the parties fulfill their obligations under the Offer in full.

9.2. The Offer may be terminated early, in cases established by this Offer and the current legislation of the Republic of Kazakhstan.
