## **Privacy Policy of the Autonomous Cluster Fund «Innovative Technologies Park »**

1.General provisions

1.1. This Privacy Policy, hereinafter referred to as the Information System Policy "astanahub.com", hereinafter referred to as the System, the mobile application of the Autonomous Cluster Fund «Innovative Technologies Park», hereinafter referred to as the Application, the site of the Digital Bridge International Forum, hereinafter referred to as the Site, defines the general conditions for processing users' personal data and clients in the System, Applications, Website and/or copies thereof.

1.2. Users of the System and / or Application are any natural or legal person who has the right to use the System and / or Application in their own interests in accordance with the requirements of the current legislation of the Republic of Kazakhstan, the User Agreement for the use of the System and / or Application.

1.3. The Autonomous Cluster Fund «Innovative Technologies Park», hereinafter referred to as the Fund, has the right to change this Policy unilaterally by posting the modified text on the Internet at the address of the System and/or Application.

1.4. Users are required to track changes to the Policy themselves.

1.5. Having started using the System and/or the Application, the User is considered to have accepted the terms of this Policy in full, without any reservations and exceptions. In case of disagreement with any of the provisions, the User does not have the right to use the System and/ or the Application.

1.6. If the User does not agree with this Policy, the User may stop using the System and/or the Application and/or the Site.

1.7. The Policy does not regulate the processing and protection of Users' personal data in relation to any sites or web objects (mobile applications) accessible through the System and/or the Application and/or the Site or to which the System and/ or the Application and/or the Site contains links. The presence or inclusion of a link to any such site or object in the System

and/or the Application and/or the Site does not imply the existence of any guarantees and assurances from the Foundation.

## 2. Processing of personal data

2.1. The Foundation processes Users' personal data for the purposes of:

providing services and/or services using the System and/or the Application and/or the Site;

providing the User with access to personalized resources of the System and/or Application and/or Site;

establishing feedback with the User, including sending notifications, requests regarding the use of the System and/or the Application and/or the Site, providing services, processing requests and requests from the User.

2.2. The Foundation may transfer the User's personal data to a third party in the following cases:

if the User has consented to the transfer of their data to a third party;

if the transfer of personal data is necessary for the provision of services and services;

• if the User uses the account of the System and/or the Application and/or the Site for authorized access to information contained in the information system operated by a third party;

if the transfer is necessary within the framework of the procedure established by the legislation of the Republic of Kazakhstan.

2.3. The Foundation and the User are obliged to take the necessary organizational and technical measures to ensure the confidentiality, integrity, safety and availability of personal data.

2.4. Users consent to the processing of personal data in the System, Application and on the Website without time limit.

2.5. Processing of the User's personal data is terminated in case of blocking and/or archiving of his/her account in the System, Application, on the Website.

2.6. Users are obliged to independently ensure the safety of their account password in the System, Application, on the Website, and be responsible for the negative consequences in the form of misuse of their personal data by third parties resulting from negligent attitude to their account password;

2.7. Users are obliged to update the personal data processed in the System and/or the Application and/or the Website in case of their change, if automatic updating of the specified data is not possible.

2.8. The User has the right to withdraw consent to the collection and processing of personal data, except for the cases provided for in paragraph 2 of Article 8 of the Law of the Republic of Kazakhstan "On Personal Data and their Protection", by submitting a corresponding application to the Fund.
